Terms of Agreement

- Term and Renewal:** The term of this Agreement is _____ (3 months trial membership or 1 year annual). Agreements with a term of twelve (12) months will be automatically renewed on a monthly basis after the end of the term, unless terminated earlier, as herein provided. Trial memberships cannot be renewed.
- Payment:** All payments must be made by cheque(s) payable to **Procter and Gamble**. Three-month trial memberships must be paid in full. Annual memberships may be paid in monthly or 3-month increments. Please note that all post-dated cheques must be submitted with the first installment. Cheques should be made for \$ _____.
- Payroll Deduction Authorization (employees of Procter and Gamble only):**
The signature here _____ authorizes Vibrant Living Fitness Centre to draw monthly dues of \$ _____ through payroll deductions. Because of the timing of these deductions, payment by personal cheques may be required until the first deduction occurs.
- Changes In Monthly Payment Amount:** Vibrant Living Fitness Centre is authorized to change the amount of the monthly payment by giving the member sixty (60) days written notice of the change. Failure on the part of the member to advise Vibrant Living Fitness Centre in writing of his/her disagreement with the change within fifteen (15) days of receipt of the notice shall be deemed to be in full acceptance of such change. If the member gives written notice of his/her disagreement with the change, as provided, this agreement shall terminate thirty (30) days from the date of the original notice of change by Vibrant Living Fitness Centre to the member. Any notice to the member shall be deemed to have been duly given in writing and sent to the location shown above unless the member has given the facility notice in writing of a new location.
- Termination:** For annual memberships, a commitment of one (1) year is required. In order to terminate this agreement, the member must deliver written notice to Vibrant Living Fitness Centre at least sixty (60) days prior to the end of the membership year; such termination shall become effective on the expiration of the then current twelve (12) month period. An annual membership may only be cancelled within the first year in the case of termination or relocation of employment or for medical reasons. Documentation from a



physician or direct supervisor will be required before the membership is terminated. After the initial year, the membership may be terminated at any time with sixty (60) days written notice delivered to Vibrant Living Fitness Centre. Memberships with terms of less than one (1) year are non refundable and may not be terminated during the term of the agreement.

- 6. **Release of Liability:** The member, including his or her heirs, assigns and personal representatives, expressly releases Health Systems Group, Vibrant Living Fitness Centre, Procter & Gamble Inc., its employees, agents, successors, and assigns from any and all claims or liability for (but not limited to):
 - (a) Personal injury or death
 - (b) Loss, damage or theft of personal property
 - (c) Occupier’s liability
 - (d) Negligence, resulting from the use of Vibrant Living Fitness Centre.

- 7. **Rules and Regulations:** The member agrees to abide by all the rules and regulations of Vibrant Living Fitness Centre and any amendments, which may be, enacted hereafter. Any breach of these rules could constitute reasons for termination of membership. The member is required to provide updated information regarding location, phone numbers, and health status.

- 8. **Supervision:** The member understands that the facility is not fully supervised and that he/she participates at his/her own risk. It is recommended to exercise with another member during unsupervised hours. The member further acknowledges that it is his/her responsibility to obtain training in the proper use of any equipment prior to any use thereof. Supervised hours will be posted at the entrance of the gym.
